Our thanks also go to Gavin for his leadership of the team over recent years.

As part of this year's meeting, Peter Glanville will give you the opportunity to hear about the work of the Maltings, his ideas for the future and the chance to ask questions. This is an important way that Members can keep up to date with our work.

- To encourage, promote, undertake or carry on the arts and strengthen the bonds of community life.

I am pleased to say that, in many areas, the Maltings is returning back to normal business following the massive interruption created by Covid.

We were very pleased that we had secured funding from the Arts Council England for a further 3 years - we are most grateful to them for their support and encouragement.

A final and special thanks go to my fellow Trustees who feely give their time to the Farnham Maltings.

As we look back at the past year, the Maltings is well placed to continue going forward and as said above, we are seeing normality returning across a wide range of our activities. However, for many of our service users, confidence is taking a long time to come back. Covid still impacts every aspect of our lives and work.

We will react to ensure the best, varied and flexible services are provided.

We will continue to invest in the Maltings to increase the range, quality and audience for theatre across the region. Much of this is in response to feedback from the public - for example the new sound system in the Great Hall.

Apart from our work in the Malting's building in Farnham, we support the South East region's venues to adapt, share knowledge, investing in artists to continue to make work in these extraordinary times, reframe how artists and companies might think and work internationally, and consider how we better use the digital world.

We have kept our responsibilities as trustees under regular review and the extraordinary general meeting in October 2022, approved new Articles of Association. These will help us to continue to properly manage the resources of the Farnham Maltings, a great local charity.

We have updated our governance model. The board has established three committees to look at the key areas of our business. This ensures the board has a good understanding of all aspects of our operations. We are also in the middle of a visioning exercise to ensure that our offering to the public is kept under constant review.

I look forward to seeing many of you at the forthcoming AGM. As usual, you will receive an update on how we are managing in these times. Do bring your comments and suggestions if you have them.
