

How to leave a legacy gift in your will

You can contact us by telephone, email or visit us in person. Just see our contact details on the back of this leaflet and we will be more than happy to discuss the legacy scheme further. Of course, we understand you may wish to seek your own professional advice. Please note that this booklet is designed to outline the scheme and is not intended to constitute legal advice. When making your will you should do so in consultation with your solicitor.



As the Farnham Maltings is a registered charity, no inheritance tax is payable on the amount of your gift, since charities are exempt from paying tax. Therefore it is worth considering that you can choose either to pay the tax to the Inland Revenue or to a charity whose work you support. You should consult a solicitor for clear advice on this issue.

There are also tax implications in leaving the residue of your estate between charitable and non-charitable beneficiaries. Again, your solicitor will be able to assist you with this.

It would help us greatly if you could let us know if you have decided to include Farnham Maltings in your will. Your reply will be treated in the strictest confidence and it is entirely up to you whether you wish to provide any details about your gift.

If you are a UK tax payer you can increase the value of your payment by ticking the declaration box below.

You can increase the value of your payment by making a Gift Aid declaration. For every *giftaid* £1 you give us, Farnham Maltings can earn an additional 25p from HM Revenue and Customs by reclaiming the tax on your subscription.

Please note that you must pay an amount of income and/or capital gains tax at least equal to the amount Farnham Maltings will reclaim on your donations in the appropriate tax year. Please inform Farnham Maltings if you cease to pay sufficient tax or if your name or residential address changes.
